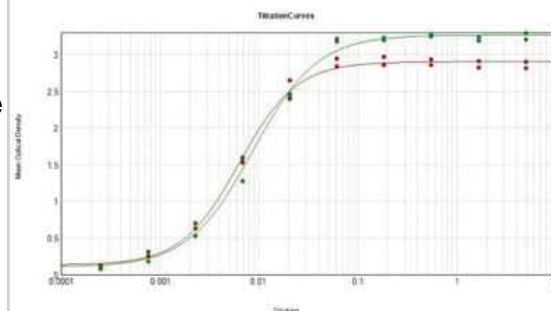

ELISA: Rabbit anti-Feline IgG Fc Secondary Antibody [NBP1-72771] - ELISA Results of Purified Rabbit anti-Feline IgG Fc Secondary antibody tested against purified CatIgG Fc. Each well was coated in duplicate with 1.0 ug of Cat IgG [Red Line] and CatIgG Fc [Green Line]. The working dilution is 1:115,000. The starting dilution of antibody was 5ug/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using HRP Conjugate Stabilizer, Goat Anti-Rabbit IgG mx10 HRP conjugated, and TMB substrate.
