Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Sheep IgG, Sheep IgG F(c) and Sheep Serum

A working dilution of 1:20,000 to 1:100,000 of the reconstitution concentration is suggested for this product. NOTE: Do NOT add Sodium Azide (it inhibits HRP irreversibly).
