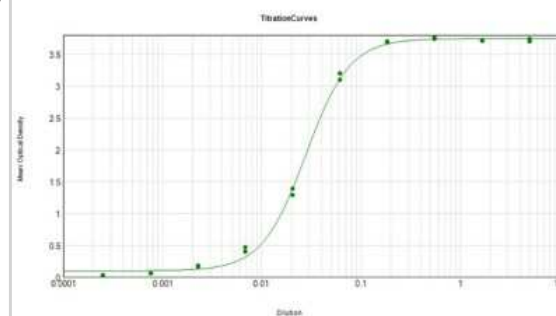

Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4C as an undiluted liquid. Dilute only prior to immediate use.</p> <p>This product was prepared from monospecific antiserum by immunoaffinity chromatography using Sheep IgG coupled to agarose. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Sheep IgG, Sheep IgG F(c) and Sheep Serum</p>

Application Notes	<p>This product has been tested by ELISA and is assayed against 1.0 ug of Sheep IgG in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiiazoline-6-sulfonic acid]) as a substrate for 30 minutes at room temperature. A working dilution of 1:2,000 to 1:8,000 of the reconstitution concentration is suggested for this product.</p> <p>NOTE: Do NOT add Sodium Azide (it inhibits HRP irreversibly).</p>

ELISA: Rabbit anti-Sheep IgG Fc Secondary Antibody [HRP] [NBP1-73550] - ELISA Results of Rabbit anti-Sheep IgG Fc Secondary antibody [HRP] tested against purified Sheep IgG Fc HRP. Each well was coated in duplicate with 1.0 ug of Sheep IgG Fc. The working dilution is 1:35,800. The starting dilution of antibody was 5ug/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using TMB substrate.
