Dilute only prior to immediate use.</p> <p>This product was prepared from normal serum delipidation, salt fractionation, ion exchange chromatography followed by pepsin digestion and extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-biotin, anti-Cat IgG, anti-Cat IgG F(ab')2 and anti-Cat Serum</p>
