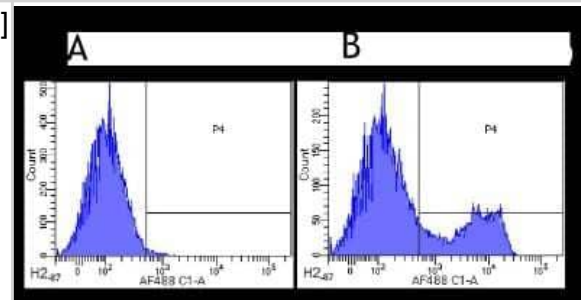

Application Notes	This antibody is Cytof ready. This chimeric rabbit antibody was made using the variable domain sequences of the original Hamster IgG2 format, for improved compatibility with existing reagents, assays and techniques. This antibody binds to murine CD3 epsilon. It partially cross-blocks binding of clone 145-2C11 indicating that overlapping epitopes are detected by these antibodies.

Flow Cytometry: CD3 epsilon Antibody (500A2) - Chimeric [NBP2-52643] - Mouse lymphocytes were stained with an anti-CD44 control (panel A) or the rabbit-chimeric version of 500A2 (panel B) at a concentration of 1 ug/ml for 30 mins at RT. After washing, bound antibody was detected using a AF488 conjugated donkey anti-rabbit antibody and cells analysed on a FACSCanto flow-cytometer.
