<b>Specificity/Sensitivity</b>	This antibody binds the extracellular domain III of the human EGFR and does not cross react with murine EGFR. It was also reported that residues S460/G461 in EGFR domain III are essential components of the epitope. This antibody binds at a site distinct from the EGF binding site, preventing conformational re-arrangement required for dimerization. This antibody can only recognize the active form of EGFR. The antibody binds to both glyco- and aglyco receptor forms.
<b>Immunogen</b>	The parental mouse antibody was generated by immunizing BALB/c mice intraperitoneally with A431 cells in phosphate buffered saline (PBS). Later on the humanized version of the antibody was created by grafting CDRs of the murine antibody onto human constant regions.
