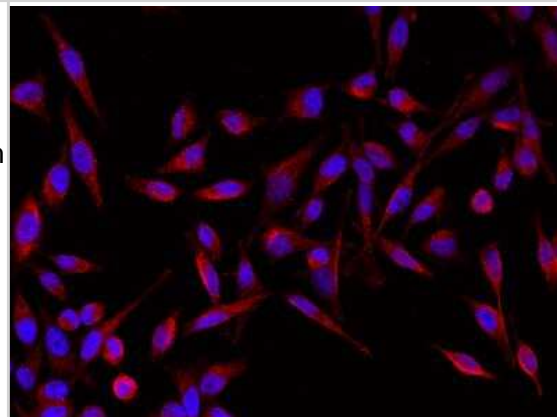

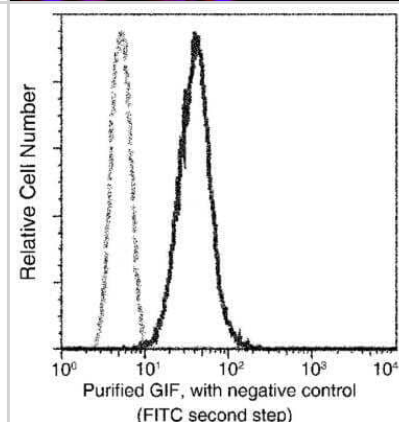

Immunocytochemistry/Immunofluorescence: GIF Antibody (007) [NBP2-90225] - Immunofluorescence staining of GIF in HeLa cells. Cells were fixed with 4% PFA, permeabilized with 0.1% Triton X-100 in PBS, blocked with 10% serum, and incubated with rabbit anti-human GIF monoclonal antibody (dilution ratio 1:60) at 4°C overnight. Then cells were stained with the Alexa Fluor(R)594-conjugated Goat Anti-rabbit IgG secondary antibody (red) and counterstained with DAPI (blue). Positive staining was localized to Cytoplasm.



Flow Cytometry: GIF Antibody (007) [NBP2-90225] - Flow cytometric analysis of Human GIF expression on HeLa cells. The cells were treated according to manufacturer's manual (BD Pharmingen™ Cat. No. 554714), stained with purified anti-Human GIF, then a FITC-conjugated second step antibody. The fluorescence histograms were derived from gated events with the forward and side light-scatter characteristics of intact cells.
