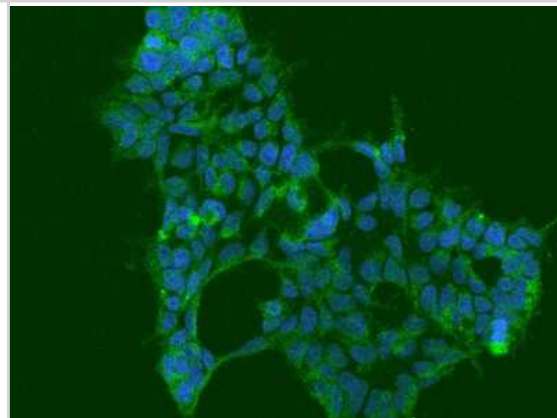

Immunocytochemistry/Immunofluorescence: Ataxin-10 Antibody [NBP2-97393] - Immunofluorescence staining of Ataxin-10 in Hek293 cells. Cells were fixed with 4% PFA, blocked with 10% serum, and incubated with rabbit anti-Human Ataxin-10 polyclonal antibody (dilution ratio 1:100) at 4C overnight. Then cells were stained with the Alexa Fluor (R)488-conjugated Goat Anti-rabbit IgG Secondary antibody (green) and counterstained with DAPI (blue). Positive staining was localized to Cytoplasm.
