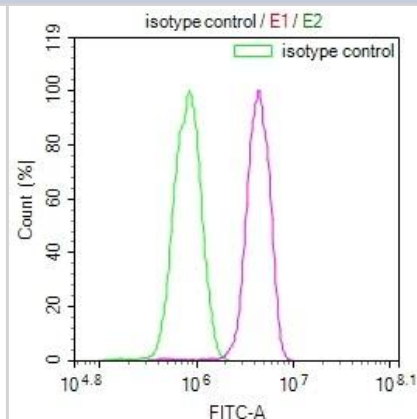

Flow Cytometry: Pentraxin 3/TSG-14 Antibody (10D9) [NBP3-26356] - Overlay Peak curve showing A549 cells stained with Pentraxin 3/TSG-14 Antibody (10D9) (red line) at 1:100. The cells were incubated in 10% normal goat serum to block non-specific protein-protein interactions followed by the antibody (1ug/1\*10<sup>6</sup> cells) for 45min at 4C. The secondary antibody used was FITC-conjugated Goat Anti-rabbit IgG (H +L) at 1:200 dilution for 35min at 4C. Control antibody (green line) was rabbit IgG (1ug/1\*10<sup>6</sup> cells) used under the same conditions. Acquisition of >10,000 events was performed.
