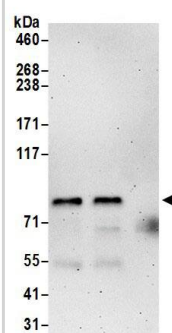

Samples: Whole cell lysate (0.5 or 1.0 mg per IP reaction; 20% of IP loaded) from 293T cells prepared using NETN lysis buffer. Antibodies: Affinity purified rabbit anti-PCIF1 antibody NBP3-29865 (lot NBP3-29865-1) used for IP at 6 µg per reaction. PCIF1 was also immunoprecipitated by rabbit anti-PCIF1 antibody BL18025. For blotting immunoprecipitated PCIF1, NBP3-29865 was used at 0.4 µg/ml. Detection: Chemiluminescence with an exposure time of 3 minutes.
