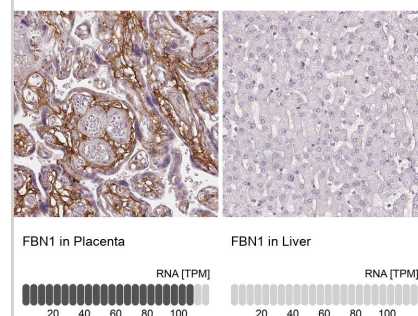

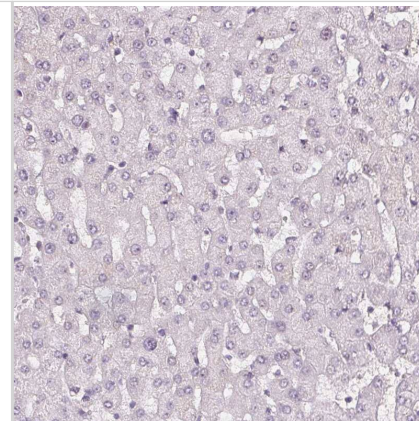

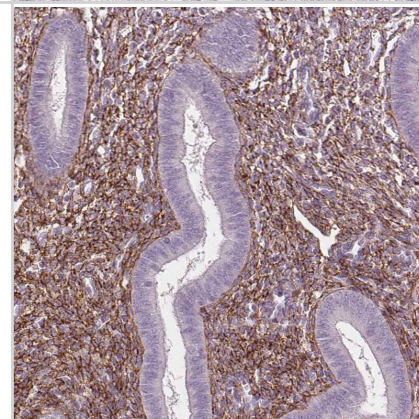
Analysis in human placenta and liver tissues using NBP3-43906 antibody. Corresponding Fibrillin 1 RNA-seq data are presented for the same tissues.



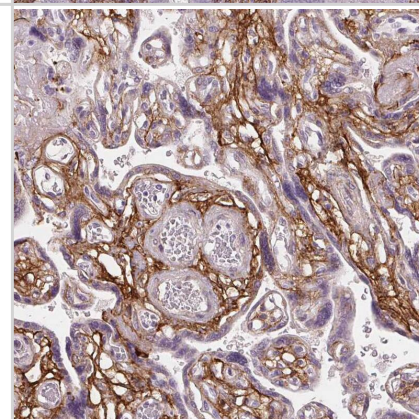
Staining of human liver shows no positivity in hepatocytes as expected.



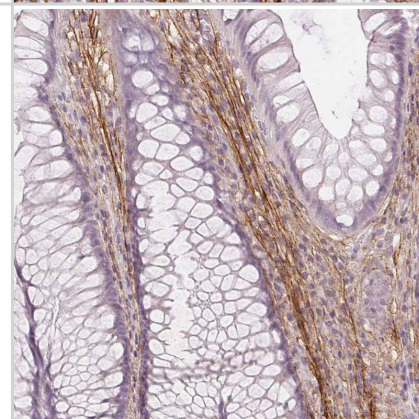
Staining of human endometrium shows strong positivity in the extracellular matrix.
