BACKGROUND

WAP four-disulfide core domain protein 2, also known as Epididymal secretory protein E4, Major epididymis-specific protein E4, Putative protease inhibitor WAP5, WFDC2 and HE4, is a secreted protein which contains two WAP domains. WFDC2 / HE4 is a member of a family of stable 4-disulfide core proteins that are secreted at high levels. It is expressed in a number of normal tissues, including male reproductive system, regions of the respiratory tract and nasopharynx. It is highly expressed in a number of tumors cells lines, such ovarian, colon, breast, lung and renal cells lines. Initially described as being exclusively transcribed in the epididymis. WFDC2 may be a component of the innate immune defences of the lung, nasal and oral cavities and suggest that WFDC2 functions in concert with related WAP domain containing proteins in epithelial host defence. WFDC2 re-expression in lung carcinomas may prove to be associated with tumour type and should be studied in further detail. Mammary gland expression of tammar WFDC2 during the course of lactation showed WFDC2 was elevated during pregnancy, reduced in early lactation and absent in mid-late lactation. WFDC2 / HE4 can undergo a complex series of alternative splicing events that can potentially yield five distinct WAP domain containing protein isoforms.

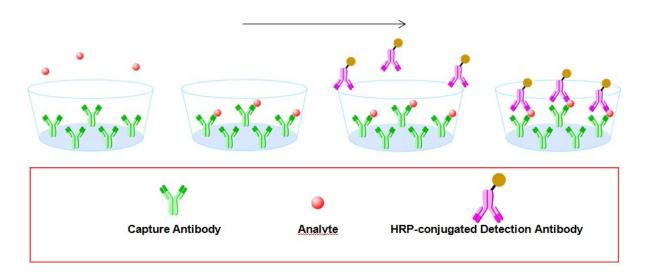
PRINCIPLE OF THE TEST

The Novus Biologicals HE4/WFDC2 Antibody Pair [HRP] is a solid phase sandwich ELISA (Enzyme-Linked Immunosorbent Assay). It utilizes a monoclonal antibody specific for Human HE4/WFDC2 coated on a 96-well plate. Standards and samples are added to the wells, and any Human HE4/WFDC2 present binds to the immobilized antibody. The wells are washed and a horseradish peroxidase conjugated rabbit anti-Human HE4/WFDC2 monoclonal antibody is then added, producing an antibody-antigen- antibody "sandwich". The wells are again washed and TMB substrate solution is loaded, which produces color in proportion to the amount of Human HE4/WFDC2 present in the sample. To end the enzyme reaction, the stop solution is added and absorbances of the microwell are read at 450 nm.

INTENDED USE

- ◆ The Human HE4/WFDC2 Antibody Pair [HRP] is for the quantitative determination of Human HE4/WFDC2.
- ◆This HE4/WFDC2 Antibody Pair [HRP] contains the basic components required for the development of sandwich ELISAs.

ASSAY PROCEDURE SUMMARY



This antibody pair has been configured for research use only and is not to be used in diagnostic procedures.

MATERIALS PROVIDED

Bring all reagents to room temperature before use.

Capture Antibody – 1 mg/mL of mouse anti-Human HE4/WFDC2 monoclonal antibody (in PBS, pH 7.4). Dilute to a working concentration of 2 μ g/mL in PBS before coating.

Detection Antibody - 0.2 mg/mL of rabbit anti-Human HE4/WFDC2 monoclonal antibody conjugated to horseradish-peroxidase (HRP) (in PBS, 50 % HRP-Protector, pH 7.4, store at 4° C). Dilute to working concentration of 0.05 µg/mL in detection antibody dilution buffer before use.

Standard – Each vial contains 50 ng of recombinant Human HE4/WFDC2. Reconstitute with 1 mL detection antibody dilution buffer. After reconstitution, store at -20°C to - 80°C in a manual defrost freezer. A seven-point standard curve using 2-fold serial dilutions in sample dilution buffer, and a high standard of 1000 pg/mL is recommended.

SOLUTIONS REQUIRED

PBS - 136.9 mM NaCl, 10.1 mM Na $_2$ HPO $_4$, 2.7 mM KCl, 1.8 mM KH $_2$ PO $_4$, pH 7.4, 0.2 μ m filtered

TBS - 20 mM Tris, 150 mM NaCl, pH 7.4

Wash Buffer - 0.05% Tween20 in TBS, pH 7.2 - 7.4

Blocking Buffer - 2% BSA in Wash Buffer

Sample dilution buffer - 0.1% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Detection antibody dilution buffer - 0.5% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Substrate Solution: To achieve best assay results, fresh substrate solution is recommended

Substrate stock solution - 10mg / ml TMB (Tetramethylbenzidine) in DMSO

Substrate dilution buffer - 0.05M Na₂HPO₄ and 0.025M citric acid; adjust pH to 5.5

Substrate working solution - For each plate dilute 250 μ l substrate stock solution in 25ml substrate dilution buffer and then add 80 μ l 0.75% H_2O_2 , mix it well

Stop Solution - 2 N H₂SO₄

PRECAUTION

The Stop Solution suggested for use with this antibody pair is an acid solution. Wear eye, hand, face, and clothing protection when using this material.

STORAGE

Capture Antibody: Aliquot and store at -20° C to -80° C for up to 6 months from date of receipt. Avoid repeated freeze-thaw cycles.

Detection Antibody: Store at 4° C and protect it from prolonged exposure to light for up to 6 months from date of receipt. **DO NOT FREEZE!**

Standard: Store lyophilized standard at $-20\,^{\circ}$ C to $-80\,^{\circ}$ C for up to 6 months from date of receipt. Aliquot and store the reconstituted standard at $-80\,^{\circ}$ C for up to 1 month. Avoid repeated freeze-thaw cycles.

GENERAL ELISA PROTOCOL

Plate Preparation

- 1. Dilute the capture antibody to the working concentration in PBS. Immediately coat a 96-well microplate with 100 μ L per well of the diluted capture antibody. Seal the plate and incubate overnight at 4 $^{\circ}$ C.
- 2. Aspirate each well and wash with at least 300µl wash buffer, repeating the process two times for a total of three washes. Complete removal of liquid at each step is essential for good performance. After the last wash, remove any remaining wash buffer by inverting the plate and blotting it against clean paper towels. 3.Block plates by adding 300 µL of blocking buffer to each well. Incubate at room temperature for a
- 4.Repeat the aspiration/wash as in step 2. The plates are now ready for sample addition.

Assay Procedure

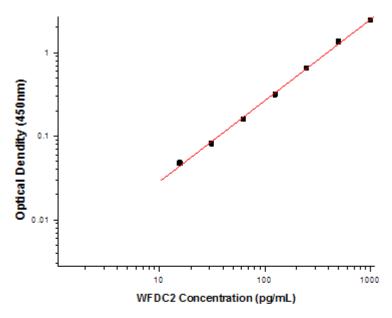
- $1.Add\ 100\ \mu L$ of sample or standards in sample dilution buffer per well. Seal the plate and incubate 2 hours at room temperature.
- 2. Repeat the aspiration/wash as in step 2 of plate preparation.
- 3. Add $100~\mu L$ of the detection antibody, diluted in antibody dilution buffer, to each well. Seal the plate and incubate 1 hour at room temperature.
- 4. Repeat the aspiration/wash as in step 2 of plate preparation.
- 5. Add $200~\mu L$ of substrate solution to each well. Incubate for 20~minutes at room temperature (if substrate solution is not as requested, the incubation time should be optimized). Avoid placing the plate in direct light.
- 6.Add 50 µL of stop solution to each well. Gently tap the plate to ensure thorough mixing.
- 7. Determine the optical density of each well immediately, using a microplate reader set to 450 nm.

CALCULATION OF RESULTS

- Calculate the mean absorbance for each set of duplicate standards, controls and samples. Subtract the mean zero standard absorbance from each.
- Construct a standard curve by plotting the mean absorbance for each standard on the y-axis against the concentration on the x-axis and draw a best fit curve through the points on the graph.
- •To determine the concentration of the unknowns, find the unknowns' mean absorbance value on the y-axis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the x-axis and read the concentration. If samples have been diluted, the concentration read from the standard curve must be multiplied by the dilution factor.
- Alternatively, computer-based curve-fitting statistical software may also be employed to calculate the concentration of the sample.

TYPICAL DATA

This standard curve is only for demonstration purposes. A standard curve should be generated for each assay.

PERFORMANCE CHARACTERISTIC

SENSITIVITY

The minimum detectable dose of Human HE4/WFDC2 was determined to be approximately **15.625 pg/ml**. This is defined as at least three times standard deviations above the mean optical density of 10 replicates of the zero standard.
