#### BACKGROUND

RNase A, also known as ribonuclease A and RNASE1, belongs to ribonuclease A superfamily. It is a pancreatic-type of secretory ribonuclease. RNase A is a basic protein and its many positive charges are consistent with its binding to RNA (a poly-anion). More generally, RNase A is unusually polar or, rather, unusually lacking in hydrophobic groups, especially aliphatic ones. As a endonuclease, RNase A cleaves internal phosphodiester RNA bonds on the 3'-side of pyrimidine bases. It prefers poly(C) as a substrate and hydrolyzes 2',3'-cyclic nucleotides, with a pH optimum near 8.0. RNase A is monomeric and more commonly acts to degrade ds-RNA over ss-RNA. Alternative splicing occurs at this locus and four transcript variants encoding the same protein have been identified.

#### PRINCIPLE OF THE TEST


The Novus Biologicals Ribonuclease A Antibody Pair [HRP] is a solid phase sandwich ELISA (Enzyme-Linked Immunosorbent Assay) for the quantitative determination of Human Ribonuclease A. It utilizes a monoclonal antibody specific for Human Ribonuclease A coated on a 96-well plate. Standards and samples are added to the wells, and any Human Ribonuclease A present binds to the immobilized antibody. The wells are washed and a horseradish peroxidase conjugated rabbit anti-Human Ribonuclease A polyclonal antibody is then added, producing an antibody-antigen- antibody "sandwich". The wells are again washed and TMB substrate solution is loaded, which produces color in proportion to the amount of Human Ribonuclease A present in the sample. To end the enzyme reaction, the stop solution is added and absorbances of the microwell are read at 450 nm.

#### INTENDED USE

◆ The Human Ribonuclease A Antibody Pair [HRP] is for the quantitative determination of Human Ribonuclease A.

 This Ribonuclease A Antibody Pair [HRP] contains the basic components required for the development of sandwich ELISAs.

#### ASSAY PROCEDURE SUMMARY



This antibody pair has been configured for research use only and is not to be used in diagnostic procedures.

#### MATERIALS PROVIDED

Bring all reagents to room temperature before use.

**Capture Antibody** – 0.5 mg/mL of mouse anti-Human Ribonuclease A monoclonal antibody (in PBS, pH 7.4). Dilute to a working concentration of 2 µg/mL in PBS before coating.

**Detection Antibody** – 0.2 mg/mL of rabbit anti-Human Ribonuclease A polyclonal antibody conjugated to horseradish-peroxidase (HRP) (in PBS, 50 % HRP-Protector, pH 7.4, store at 4°C). Dilute to working concentration of 0.25  $\mu$ g/mL in detection antibody dilution buffer before use.

**Standard** – Each vial contains 85 ng of recombinant Human Ribonuclease A. Reconstitute with 1 mL detection antibody dilution buffer. After reconstitution, store at  $-20^{\circ}$ C to  $-80^{\circ}$ C in a manual defrost freezer. A seven-point standard curve using 2-fold serial dilutions in sample dilution buffer, and a high standard of 8000 pg/mL is recommended.

#### SOLUTIONS REQUIRED

**PBS** - 136.9 mM NaCl, 10.1 mM Na<sub>2</sub>HPO<sub>4</sub>, 2.7 mM KCl, 1.8 mM KH<sub>2</sub>PO<sub>4</sub>, pH 7.4, 0.2 μm

filtered

**TBS** - 20 mM Tris, 150 mM NaCl, pH 7.4

Wash Buffer - 0.05% Tween20 in TBS, pH 7.2 - 7.4

Blocking Buffer - 2% BSA in Wash Buffer

Sample dilution buffer - 0.1% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Detection antibody dilution buffer - 0.5% BSA in wash buffer, pH 7.2 - 7.4, 0.2 µm filtered

Substrate Solution : To achieve best assay results, fresh substrate solution is recommended

Substrate stock solution - 10mg / ml TMB ( Tetramethylbenzidine ) in DMSO

Substrate dilution buffer -  $0.05M Na_2HPO_4$  and 0.025M citric acid ; adjust pH to 5.5

Substrate working solution - For each plate dilute 250 µl substrate stock solution in 25ml

substrate dilution buffer and then add 80  $\mu$ l 0.75% H<sub>2</sub>O<sub>2</sub>, mix it well

Stop Solution - 2 N H<sub>2</sub>SO<sub>4</sub>

#### PRECAUTION

The Stop Solution suggested for use with this antibody pair is an acid solution. Wear eye, hand, face, and clothing protection when using this material.

#### STORAGE

**Capture Antibody**: Aliquot and store at -20  $^{\circ}$ C to -80  $^{\circ}$ C for up to 6 months from date of receipt. Avoid repeated freeze-thaw cycles.

**Detection Antibody**: Store at  $4^{\circ}$ C and protect it from prolonged exposure to light for up to 6 months from date of receipt. **DO NOT FREEZE!** 

**Standard**: Store lyophilized standard at -20  $^{\circ}$ C to -80  $^{\circ}$ C for up to 6 months from date of receipt. Aliquot and store the reconstituted standard at -80  $^{\circ}$ C for up to 1 month. Avoid repeated freeze-thaw cycles.

#### **GENERAL ELISA PROTOCOL**

#### **Plate Preparation**

1. Dilute the capture antibody to the working concentration in PBS. Immediately coat a 96-well microplate with 100 $\mu$ L per well of the diluted capture antibody. Seal the plate and incubate overnight at 4°C.

2. Aspirate each well and wash with at least 300µl wash buffer, repeating the process two times for a total of three washes. Complete removal of liquid at each step is essential for good performance. After the last wash, remove any remaining wash buffer by inverting the plate and blotting it against clean paper towels. 3.Block plates by adding 300 µL of blocking buffer to each well. Incubate at room temperature for a minimum of 1 hour.

4.Repeat the aspiration/wash as in step 2. The plates are now ready for sample addition.

#### Assay Procedure

1.Add 100  $\mu$ L of sample or standards in sample dilution buffer per well. Seal the plate and incubate 2 hours at room temperature.

2. Repeat the aspiration/wash as in step 2 of plate preparation.

3. Add 100 µL of the detection antibody, diluted in antibody dilution buffer, to each well. Seal the plate and incubate 1 hour at room temperature.

4. Repeat the aspiration/wash as in step 2 of plate preparation.

5. Add 200  $\mu$ L of substrate solution to each well. Incubate for 20 minutes at room temperature ( **if substrate solution is not as requested, the incubation time should be optimized**). Avoid placing the plate in direct light.

6. Add 50  $\mu$ L of stop solution to each well. Gently tap the plate to ensure thorough mixing. 7. Determine the optical density of each well immediately, using a microplate reader set to 450 nm.

#### CALCULATION OF RESULTS

• Calculate the mean absorbance for each set of duplicate standards, controls and samples. Subtract the mean zero standard absorbance from each.


• Construct a standard curve by plotting the mean absorbance for each standard on the y-axis against the concentration on the x-axis and draw a best fit curve through the points on the graph.

•To determine the concentration of the unknowns, find the unknowns' mean absorbance value on the yaxis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the x-axis and read the concentration. If samples have been diluted, the concentration read from the standard curve must be multiplied by the dilution factor.

•Alternatively, computer-based curve-fitting statistical software may also be employed to calculate the concentration of the sample.

#### **TYPICAL DATA**

This standard curve is only for demonstration purposes. A standard curve should be generated for each assay.

#### PERFORMANCE CHARACTERISTIC

#### SENSITIVITY

The minimum detectable dose of Human Ribonuclease A was determined to be approximately **125 pg/ml**. This is defined as at least three times standard deviations above the mean optical density of 10 replicates of the zero standard.

	The concentration of antigen in samples was too low	Enriching samples to increase the concentration of antigen
